DEFERRED DEPOSIT INSTRUCTIONS

PLEASE READ ALL INFORMATION BELOW BEFORE REQUESTING DEFERRED DEPOSIT

UCLA Summer Sessions deferred deposit program allows qualifying students to enroll in one of our programs and delay payment for the \$350 registration fee until after scholarship awards are announced. To qualify for deferred deposit, you must meet at least one of the following qualifications:

- Current recipient of the State of California (CalFresh) or U.S. Public Assistance (food stamps, cash, and/or medical assistance).
 Documentation Required: Copy of EBT Card and photo ID or other proof of benefits
- Family Annual Gross Income below \$60,000.

 Documentation Required: Page 1 of parent/guardian(s) Federal Income Tax Form (1040). Black-out all social security numbers
- Participant in the Free and Reduced Lunch Program.
 Documentation Required: Copy of lunch tickets with name or official letter from the High School that the student currently attends

Dates: Students may apply for a deferral from February 15th through April 1st.

DEFFERED DEPOSIT STEPS

To apply for deferred deposit:

- 1) Fully read the Terms and Conditions listed on Page 2 of this document.
- 2) Register for a UCLA Summer Sessions <u>summer course</u>, the <u>Summer College Immersion</u> Program, or a Precollege Summer Institute.
- 3) Email confidential@summer.ucla.edu ONE of the following documents:
 - Copy of EBT Card and photo ID
 - Page 1 of parent/guardian(s) Federal Income Tax Form (1040). **Black-out all social security numbers**
 - Copy of lunch tickets with name or official letter from the High School that the student currently attends

The subject of the email should be "**Deferred Deposit Request**." In the email, please include your five-digit registration number and the required document as an attachment.

HOW WILL I BE NOTIFIED

UCLA Summer Sessions will review all deferred deposit requests and verify eligibility. You will be notified via email within one week of submission that your request has been approved or denied. If approved, the \$350 registration fee will be deferred, and you will be enrolled in a Precollege Summer Institute, the Summer College Immersion Program (SCIP), or granted access to enroll in summer courses (space permitting).

NOTE: If registering for a Precollege Summer Institute or the Summer College Immersion Program (SCIP), deferred deposit will not apply until you are accepted into the program. If your program or course is waitlisted, you may add yourself to the waitlist.

If you are not eligible for deferred deposit, you will be notified via email and will be required to pay the \$350 registration fee for consideration of the Summer Scholars Support.

TERMS AND CONDITIONS

- 1) Receiving deferred deposit does **not** guarantee a scholarship. You must still apply for Summer Scholars Support and your scholarship application will be reviewed equally with the other applicants.
- 2) You must complete and submit all requirements for Summer Scholars Support by the appropriate deadline or you will be dropped from your Summer Institute, SCIP, or summer course.
- 3) If you are not awarded a scholarship, you will be required to pay the \$350 fee within 24 hours or you will be dropped from your program or academic course.
- 4) If eligible, students can only defer their deposit for one program.
- 5) If a partial scholarship is awarded, the student must pay the difference by May 1 or you will be dropped from your program or academic course.
- 6) Providing false or incorrect information to the University is grounds for exclusion from consideration for the Summer Scholars Support award and immediate cancellation of Summer Sessions registration.
